### APPLICATION FOR TRANSFER OF PREMISES LICENCE

Licensing (Scotland) Act 2005, Sections 33, 34 and 35

### Notes:-

- (1) Your application must be accompanied by the original of the Premises Licence or, if that is not practicable, a statement of the reasons for failure to produce the licence. The Summary is not an acceptable substitute for the Premises Licence but please also submit the Summary to the Board.
- (2) In addition to applying to transfer the Premises Licence, you may also require to apply for a Variation to substitute a new premises manager and/or you may wish to apply for a Variation of the Premises Licence for other matters such as contained in the Operating Plan, Layout Plan, or local conditions.
- (3) There are two separate ways to apply for the transfer of a Premises Licence, Section 33 of the Licensing (Scotland) Act 2005 for Transfer on the application of the licence holder (to another person, the transferee) and Section 34 for Transfer on the application of a person other than the licence holder. Section 34 covers transfers applied for within 28 days of a specified event.
