BUDGET STATEMENT

ABSTRACT

The Common Good Fund Committee is requested to approve the Auchterarder Common Good Fund Budget for Financial Year 2012/13.

1. **RECOMMENDATION**

The Committee is requested to approve the Auchterarder Common Good Fund Budget for Financial Year 2012/13.

2. BACKGROUND

This report has been prepared using Perth and Kinross Council's General Ledger 2011/12.

3. CONSULTATION

No consultation has been carried out on this report.

4. **RESOURCE IMPLICATIONS**

4.1 <u>Expenditure</u>

• Financial Assistance

The proposed budget is retained at the same level as 2011/12.

• Christmas Lighting

The proposed budget has been reduced by £1,000 based on expenditure incurred in 2011/12.

• Administration Recharge

The proposed budget has been increased by £75 to reflect an increase in the overall recharge.

4.2 Income

• Rents

The proposed budget has increased by $\pounds 2,000$ based on income received in 2011/12.

Interest Earned

The proposed budget has been reduced to £600 as a result of low interest rates.

4.3 On the basis of the attached report, it is anticipated that a surplus of £3,200 will be incurred in 2012/13 and the Fund's estimated Revenue Account Balance will be £293,325 at 31 March 2013.

5. COUNCIL PRIORITIES AND PRINCIPLES

The information contained in this report has been prepared in accordance with the criteria for the management of Auchterarder Common Good Fund.

6. COUNCIL CORPORATE PLAN OBJECTIVES 2009 - 2012
