<b>Standard</b>	<i>All groups that do not fall under the Concession criteria; groups where instructor retains income.</i>
<b>Junior</b>	<i>Under 18 activities</i>
<b>No Charge</b>	<i>All Council Services; Parent Councils/Elections; Kids Club (non-profit-making).</i>
<b>Commercial</b>	<i>Individuals or commercial groups/organisations who are profit-making - price on request.</i>
<b>Surcharges</b>	<i>Surcharges will be charged on a full cost recovery basis for lets finishing out with normal operating hours or advertised locations/evenings and for any additional cleaning required.</i>
<b>VAT on Sporting and Recreational Lets</b>	<i>VAT is chargeable at the current rate on <b>sporting/physical recreation lets</b> as per the conditions set out in Section 5 of HMRC Notice 742 Land and Property.
