ABSTRACT

The Common Good Fund Committee is requested to note the Crieff Common Good Fund Income and Expenditure to 30 November 2012 and the projected outturn to 31 March 2013.

1. **RECOMMENDATION**

The Committee is requested to note the expenditure incurred and income received for the period up to 30 November 2012 and the projected outturn to 31 March 2013.

2. BACKGROUND

This report has been prepared using the Perth and Kinross Council General Ledger for 2012/13.

3. CONSULTATION

No consultation has been carried out on this report.

4. **RESOURCE IMPLICATIONS**

On the basis of the attached report, it is anticipated that a surplus of \pounds 2,883 will be generated in financial year 2012/13 and the Fund's Revenue Account Balance is estimated to be \pounds 4,382 at 31 March 2013.

The information contained in this report has been prepared in accordance with the criteria for the management of Crieff Common Good Fund.
