The Common Good Fund Committee is requested to note the Auchterarder Common Good Fund Income and Expenditure to 8 February 2013 and the projected outturn to 31 March 2013.

1. RECOMMENDATION

The Committee is requested to note the expenditure incurred and income received for the period up to 8 February 2013 and the projected outturn to 31 March 2013.

2. BACKGROUND

This report has been prepared using the Perth and Kinross Council General Ledger for 2012/13.

3. CONSULTATION

No consultation has been carried out on this report.

4. RESOURCE IMPLICATIONS

On the basis of the attached report, it is anticipated that a surplus of £15,151 will be achieved in financial year 2012/13 and the Fund's estimated Revenue Account Balance will be £311,494 at 31 March 2013.
