2013/14 FINANCIAL STATEMENT

Joint Report by Head of Finance & Executive Director (Environment)

PURPOSE OF REPORT

This report details the Income and Expenditure to 2 September 2013 and the projected outturn to 31 March 2014 and seeks approval of re-active maintenance expenditure.

1. BACKGROUND / MAIN ISSUES

1.1 The Committee approved the budget at the meeting of 1 May 2013. This report provides the monitoring position and projected outturn for the Financial Year 2013/2014.

2. PROPOSALS

2.1 Financial Statement 2013/14

On the basis of Appendix 1, it is anticipated that a surplus of £2,715 will be generated in financial year 2013/14 and the Fund's Revenue Account Balance is estimated to be £316,818 at 31 March 2014.

2.2 Re-Active Maintenance

Auchterarder Common Good receive an income of £2,600 for the lease of a field which has flooded recently due to damaged pipe work which requires replacement. A provisional sum of £500 has been included within the Financial Statement to reflect this.

3. CONCLUSION AND RECOMMENDATION

- 3.1 The Committee is requested to note the Auchterarder Common Good Fund Income and Expenditure to 2 September 2013 and the projected outturn to 31 March 2014.
- 3.2 The Committee is requested to approve the expenditure associated with the maintenance works detailed in section 2.2.
