Built Environment

1 Built Environment

The initiative will contribute towards a high quality, well-designed built environment that complements the distinctive and historic local character?



Mixed - partly true, but some way to go

Justification:

The programme will retain 3 properties within Perth City Centre. Pullar House, 2 High Street and Cerpenter House. Both 2 High Street and Pullar House are listed buildings. The works within 2 High Street will address maintenance and compliance issues within the facility. Within the scope is a review of the issues relating to the Diability Discrimination Act. This will ensure the building can remain oprational for PKC, and ensure that a significant location within the High Street can be retained.

The proposed changes within Pullar House will modify the floor finishes within the East Atrium, the listed stone floor does not enhance the acoustics in the building, and we plan to make alterations to this.

During the programme the Council will occupy 43% less spac. Council and committee meetings currently held withn 2 High Street will require to be decanted during the works. Members of the Public accessing Licensing Services in 2 High Street will require to go to alternative locations during the works.

Mitigation:

Whilst works are carried out it is proposed that occupants of 2 High Street decant to the Atrium, Blackfriars, and Pullar House facilities. Council and Committee meetings will be accommodated in the Dewars Conference Centre. This facility is DDA compliant and meets the needs of the defined Council requirements. It is proposed that members of the Public requiring to access Licensing Services will require to go to the 'one stop shop' Service desk within Pullar House.




As the Council consolidates from 7 buildings to 3 the amount of space occupied will reduce by 20%. The reduction from 21236 sq m to 17054 sq m will remove the need to heat, light, maintain, the spaces previously occupied. Reducing the Councils utility / energy costs / consumption. Further carbon savings through reduced travel within Perth will also create carbon savings.

Mitigation:

A review of utility costs from all properties within scope has identified a potential energy reduciton of 25%. The scope fo work within the retained properties will not however improve the energy efficieny of the facilities being retaine, ie no alterations to U values.

The consolidation of the estate from 7 buildings to 3 will reduce the number of facilities which members of the public require to visit, reducing confusion over where to find the Council, and how to access the Council for face to face enquiries. During the decant period Member of the public will be able to gain access to Council Services either via the One Stop Shop Service Desk in Pullar House, or attend Council meetings within the Dewars Conference facility.

Mitigation:

The use of the Dewars conference facility will ensure the Council have sufficient space and appropriate facilities dueing the decant period whilst 2 High Street compliance works are carried out. On completion of 2 High Street members of the public will gain access as they currently do, with the exception of Licensing which may be retained in Pullar House. The Programme team will work with PKC communications to ensure al stakeholders are informed of the changes proposed.

Mitigation:

The programme team are working with the PKC waste strategy team to enusre material are recycled as far as possible, before any waste goes to landfill. The waste strategy team are also reviewing the process for disposing of paper in an appropriate manner.



The design of changes to the office environment will require to provide ergonomically adaptable solutions to ensure all User needs are considered. The existing office environment within Perth is compliant, the future office environment will also be compliant.

To prepare staff for their relocation to the new office environment, a Business Change team have been appointed. This team will ensure all stakeholders are engaged through a detailed communication plan to prepare staff for their relocation to the new environment.

Mitigation:

Space planning proposals being developed are based upon a consistent approach to space allocation, to enusre we do not create environments similar to the HCC space on the 1st floor of Pullar House. To improve the space allocation per person the programme has received approval to modify the archive area on the 2nd floor into usable office space.

Within Pullar House and Carpenter House, improved staff welfare (tea / coffee) facilities are proposed on every floor, this will reduce the pressure on the existing single kitchens located on each floor, which reult in staff having to go through several dooors, whilst carrying hot drinks / hot food.
