PROPOSED TIMETABLE OF MEETINGS 2015 AND INDICATIVE TIMETABLES 2016-2017

Report by Head of Democratic Services

PURPOSE OF REPORT

This report provides an update on the operation of the 2014 Committee cycle and seeks approval of a timetable for meetings for 2015 and indicative timetables for 2016 and 2017.

1. BACKGROUND / MAIN ISSUES

- 1.1 Since 2007, the Council has successfully operated an eight weekly cycle of committee meetings. In addition to this, the Development Management Committee operates on a four weekly basis, the Licensing Committee on a six weekly basis, and the Local Review Body meets approximately every four weeks. Timetables have also continued to take account of fixed recess periods at Easter, summer and October holiday periods.
- 1.2 The 2014 timetable has worked well and helped facilitate an increasing number of other meeting commitments for elected members and officers.
- 1.3 It has been normal practice to submit a report to Council in October of each year putting forward a proposed timetable of meetings for the following year, however, as part of forward planning for 2015 in line with the Perth Office Programme, this report is presented in June 2014 to enable preparations to begin over the summer recess period.

2. PROPOSED TIMETABLE

- 2.1 In continuing similar practice to previous years, the first meeting of the Housing and Health Committee has been timetabled to take place on 21 January 2015 to enable consideration of any proposed rent changes. A special meeting of the Council for setting the budget has been included provisionally for 12 February 2015. As introduced in 2014, scheduled dates for meetings of the Appeals Sub-Committee have been inserted for each month, however these meetings may not take place.
- 2.2 Some amendments have been made to the 2015, 2016 and 2017 timetables that were indicatively presented to Council in October 2013, namely the scheduling of the Audit Committee in August / September to take account of External Audit reporting timescales, and the meeting of the Community Safety Committee in January to assist with reporting arrangements.

3. CONCLUSION AND RECOMMENDATIONS

- 3.1 This report outlines the committee cycle for 2015 and provides details of the indicative timetables for 2016 and 2017 (up to the local government elections).
- 3.2 It is recommended that the Council:
 - (i) Approve the timetable for meetings for 2015 as set out in Appendix 1 of this report.
 - (ii) Approves the indicative timetables for 2016 and 2017 (up to the local government elections) as set out in Appendices 2 and 3 of this report.
