1. APOLOGIES

Apologies were submitted and noted as above.

2. DECLARATIONS OF INTEREST

3. MINUTE OF MEETING OF CHILDREN AND YOUNG PEOPLE'S STRATEGIC PARTNERSHIP OF 2 SEPTEMBER 2013.

The minute of meeting of the Children and Young People's Strategic Partnership of 2 September 2013 was submitted and noted.

4. MATTERS ARISING

(i) STV/Hunter Partnership (paragraph 4 refers)

B Atkinson provided the Group with an update on his discussion with Martin Crewe the Director of Barnardos Scotland regarding the pilot community development initiative.

Following discussion the Group agreed that the Muirton/North Muirton area within the North Perth city ward, and Stanley within the Perth Grammar School catchment area, be selected as the preferred areas for the pilot community development initiative.

5. EVIDENCE2SUCCESS PROGRESS REPORT

There was submitted a report by the Depute Director (Education and Children's Services) (G/13/244) providing a summary of the progress achieved in the development and delivery of Evidence2Success since the last meeting of the Group on 2 September 2013. The report also provided: (1) an analysis of information gained through the Evidence2Success Well-being Surveys; and (2) proposals for the introduction of parenting programmes that will in time be delivered for all eligible families.

Following discussion, the Group:

- Requested a Youth Event be developed to engage young people in Evidence2Success.
- Agreed that Joan Wilson provide a presentation to the Early Years

 Partnership in Perth and Kinross.
- Agreed to consider funding opportunities such as the Big Lottery and other charitable bodes to support Evidence2Success work.

The Group received a presentation from Fiona Mackay, Perth and Kinross Council on the Early Years Collaborative.

7. PERTH AND KINROSS CHILD PROTECTION COMMITTEE (CPC) – CHILDREN'S RIGHTS

There was submitted a report by the Executive Director (Education and Children's Services) (G/13/242) presenting: (1) a summary of the proposed legislative provisions to promote children and young people's rights contained within the Children and Young People (Scotland) Bill. The report also detailed the views of children and young people on children protection systems in

Scotland as evidenced from published research and the current provisions and working ongoing across Perth and Kinross.
