# **School Estate Capital Programme Progress Update**

# Report by Executive Director (Education and Children's Services)

# **PURPOSE OF REPORT**

This report updates Committee on the progress and proposals for delivering the current school projects within the Education and Children's Services Capital Programme. It details key milestones which have been achieved since the last update to Committee on 20 November 2014.

#### 1. BACKGROUND/MAIN ISSUES

- 1.1 The School Estate Strategy sets out the Council's aspirations for our schools, and in particular the high value we place on learning, through our vision for well designed, maintained and managed schools.
- 1.2 The strategy is delivered through the School Estate Management Plan (SEMP) which is primarily funded through the Council Capital Programme.
- 1.3 The Education and Children's Services (ECS) Capital Programme details the priorities for the School Estate over a rolling seven year period and is reviewed on an annual basis.

# 2. PROPOSALS

- 2.1 This report updates Committee on progress and proposals for delivering the current capital projects within Education and Children's Services School Estate Programme. The focus of the programme is on:
  - Primary School Upgrades
  - Secondary School Upgrades
  - Other ECS Capital Projects
  - Design Build Finance & Manage (DBFM) Projects

## 3. UPDATES ON CURRENT PROGRAMME

3.1 Detailed updates on current projects are provided in Appendix A. The following projects have reached significant milestones since the previous School Estate Sub-Committee on 20 November 2014.

# **Significant Milestones – Primary School Upgrade Programme**

# 3.2 **Alyth Primary School**

Site investigations have been undertaken to inform the concept design received on 25 November 2014. The stage 1 report has been analysed and was formally accepted on 19 February 2015.

The concept design was shared with the User Reference Group on 11 December 2014 and was well received. An informal drop-in session was held on 26 January 2015 where the design was shared with Parents/Carers and the wider school community.

# 3.3 **Errol Primary School**

The Statutory consultation for the specialist provision for Additional Support Needs was undertaken between 7 January 2015 and 27 February 2015. Final approval will be sought from the Lifelong Learning Committee once consultation has concluded.

# 3.4 Oakbank Primary School

The Statutory consultation for the specialist provision for Additional Support Needs at Oakbank Primary School was also undertaken. Final approval will be sought from the Lifelong Learning Committee once consultation has concluded.

# Significant Milestones – Other Education and Children's Services (ECS) Capital Projects

# 3.5 Early Learning and Childcare – 600 hours and Two Year Olds Accommodation

Following a report to Lifelong Learning Committee on 29 May 2013 (Report No.13/244 refers) regarding the proposals within the Children and Young People (Scotland) Act 2014, a review of the suitability of nursery accommodation to deliver the Early Learning and Childcare requirements of the Act has been progressed.

These requirements include free early learning and childcare provision for two year olds where a parent or carer is in receipt of certain benefits, looked after 2 year olds and increasing the hours of provision for 3-4 year olds from 475 to 600 hours per annum.

Phase 1 works are complete with 11 schools being modified to accommodate the provision of two year olds.

Phase 2 works are currently being planned and premises have been identified to further extend provision for two year olds (with a focus in this Phase on using our HUB nurseries and extended provisions) which will minimise transitions and provide consistency of support for children and families. Feasibility studies are currently being considered at:

- Breadalbane Academy (Primary);
- Goodlyburn Primary;
- · Kinross Primary;
- Letham Primary;
- Methven Primary;
- Newhill Primary;
- St. John's Academy (Primary).

Provision at Alyth Primary and Errol Primary will be incorporated into the new school/upgrade builds as they are being progressed. Work will require to be done at the new Crieff and Oakbank builds after the initial snagging work is complete to plan for accommodating two year old provision in each.

# Significant Milestones – Design, Build, Finance and Manage (DBFM) Programme

In a DBFM contract, the contractor (Sub HubCo/Tier 1) is responsible for designing, building, financing, and managing the project.

In terms of financing the project this is comparable to the old Public Private Partnership (PPP)/Private Finance Initiative (PFI) approach in that a percentage of the capital cost and the full lifecycle and hard facilities management costs are financed through a borrowing arrangement.

In respect of management, this relates to the delivery of the project and the ongoing maintenance in terms of hard Facilities Management (FM) services (plant, building fabric etc. but excluding soft FM services – catering, janitorial support and cleaning).

3.6 It is the intention that the DBFM projects (New Secondary School, Kinross Primary School and Tulloch Primary School) will be consolidated under a single programme.

The procurement process has commenced for Tier 2 Consultants of the design team, comprising Architects, Mechanical & Electrical and Civil & Structural.

# 3.7 **New Secondary School**

The Statutory Consultation period ended on 19 November 2014 and the next stage of the process was for Education Scotland to review the educational aspects of the proposal and the responses to the consultation. The final report has now been received from Education Scotland. Education and

Children's Services is now preparing a final consultation report for Lifelong Learning Committee on 27 May 2015.

# 3.8 Kinross Primary School and Tulloch Primary School

Enabling funding of £100,000 has been received from East Central Hub to assist with the development work associated with these projects.

# 3.9 Forward Planning – East Central Hub

East Central Hub participants were offered the opportunity to access strategic support services, funded through the East Central Hub. The intention is that participants would use these resources to develop projects which would form part of any future capital programme, or to further develop projects which are part of the existing capital programme. Consequently, a bid was submitted to the East Central Hub for options appraisal, feasibility and development work to be undertaken to support school estate planning as follows:

- Options Appraisal & Feasibility Studies to support increased capacity;
- Costed development programmes to improve suitability and condition; and
- New requirements in terms of Early Years and Additional Support Needs.

The proposals above would facilitate more detailed and robust forward planning for the School Estate. It will also support Education and Children's Services in bidding for capital resources to improve the School Estate at a national and local level, and also in ensuring that best value is achieved from current and future funding.

HubCo has confirmed that £70,000 of resources has been allocated to Perth and Kinross Council as part of an initial allocation of funding. The remaining balance of £130,000 of resources is expected to be announced in the coming months, although this is subject to confirmation. It should be noted this is in addition to the funding for Kinross Primary School and Tulloch Primary School.

## 4. CONCLUSION AND RECOMMENDATIONS

- 4.1 This report updates School Estate Sub-Committee on progress of the Education and Children's Services School Estate capital projects approved through the Capital Programme for 2014/15 to 2020/21.
- 4.2 This Committee is requested to note that significant milestones have been achieved since the previous Committee meeting in November 2014 including:
  - Stage 1 acceptance of the Alyth Primary School project (3.2);
  - The Statutory consultation for specialist provision for Additional Support Needs was undertaken between 7 January 2015 and 27 February 2015 for Errol Primary School (3.3) and Oakbank Primary School (3.4). Final approval will be sought from the Lifelong Learning Committee once consultation has concluded.

- Projects being planned as part of Phase 2 work to meet the Council's statutory obligation in relation to Early Learning and Childcare for eligible 2 year olds and all 3 and 4 year olds (3.5); and
- The Statutory consultation period for the New Secondary School ended on 19 November 2014 and the final report has been received from Education Scotland (3.7).

## 4.3 It is recommended that the Committee notes that:

- It is the intention that the DBFM projects will be consolidated under a single programme (3.6);
- Enabling funding of £100,000 has been received from East Central Hub for development work within the Kinross Primary and Tulloch Primary projects (3.8); and
- HubCo has confirmed that £70,000 of resources has been allocated as part of an initial allocation of funding for strategic support services to allow options appraisals and feasibility studies to be undertaken as part of forward planning of the school estate. The remaining balance of £130,000 of resources is expected to be announced in the coming months, although this is subject to confirmation (3.9).

# 2. Resource Implications

# Financial

- 2.1 The Council set a 7 year Capital Budget for 2013/14 to 2019/20 at its meeting on 14 February 2013 (report 13/54 refers). Revisions to the budget for these 7 years have been considered by the Strategic Policy and Resources Committee throughout the year. The meeting of the Council on 13 February 2014 approved the Composite Capital Budget 2020/21 (report 14/45 refers). Additional capital funding has been received from the Scottish Government in 2014 for the implementation of capital works associated with the Children and Young People (Scotland) Act 2014. These monies for Early Learning and Childcare currently total £3,724,600 (a further £829,000 is expected in 2015/16 which would give an overall total of £4,553,600) and £250,000 for Free School Meals.
- 2.1.1 Any additional revenue implications identified through either the existing capital programme, or future capital programmes, with the exception of the new secondary school, will required to be submitted as part of an expenditure pressure with a corresponding saving through the ECS revenue budget process. The new secondary school revenue implications will be considered by the full Council.
- 2.1.2 There are no direct financial implications arising from this report other than those reported within the body of the main report and related business cases.

# **Workforce**

2.2 There are no direct workforce implications arising from this report.

# Asset Management (land, property, IT)

2.3 There are no direct asset management implications arising from this report other than those reported within the body of the main report.

The purpose of the URG is to assist with providing relevant local input to allow the Design Team to develop the outline concept design into an operational design. The formation of a URG is an invaluable source of information, and any project is reliant on this level of local detail.

#### **ALYTH PRIMARY SCHOOL**

Reporting Period: December 2014 to February 2015

#### Overview

Alyth Primary School is a largely life-expired property requiring major investment. The school has been identified as having the highest maintenance requirement of any primary school in Perth and Kinross. It is also under-utilised and inefficient in terms of layout and running costs.

The recommended option to upgrade the Victorian building and add a new-build element was approved at Lifelong Learning Committee on 29 January 2014 (Report 14/22 refers). It is anticipated the new school will be operational in school session 2016/17.

## **Sources of Funding**

This project will be fully funded by the ECS Composite Capital Programme. The funding for this project is £8,800,000. Additional funding will be provided from the Extend/Enhance Specialist Provision budget (for Additional Support Needs) and Early Years (for 2 year olds) when final costs are known.

# **Progress Update**

Site investigations have been undertaken to inform the concept design received on 25 November 2014. The stage 1 report has been analysed and was formally accepted on 19 February 2015. An informal drop-in session was held on 26 January 2015 where the design was shared with Parents/Carers and the wider school community.

The concept design was shared with the User Reference Group on 11 December 2014 and was well received.

#### **CRIEFF PRIMARY SCHOOL**

Reporting Period: December 2014 to February 2015

## Overview

Following the outcome of a statutory consultation exercise, Lifelong Learning Committee approved that education provision at the existing Crieff Primary School is relocated to a new school on the site adjacent to Strathearn Community Campus from August 2015 (Report 12/486 refers).

The school will initially comprise of 15 classes with the infrastructure and capacity to increase to a triple stream in the future if required.

Along with Oakbank Primary School, this school is being procured and developed through a HubCo Design & Build Development Agreement (DBDA).

# **Sources of Funding**

This project is being fully funded by the ECS Composite Capital Programme. The total project budget is £11.806m including land purchase.

# **Progress Update**

Enabling works began on the site of the new primary school in Crieff on 24 March 2014. Financial Close was achieved on the project on 9 May 2014 and the main contractual works began thereafter.

# DESIGN, BUILD, FINANCE AND MANAGE (DBFM) PROGRAMME

## 1. NEW SECONDARY SCHOOL

Reporting Period: December 2014 to February 2015

## Overview

A review of the School Estate has taken place to determine the likely impact of anticipated population growth on the school estate in the medium to long term. One of the priorities for the Council has been agreed as a secondary school on the northern perimeter of Perth. The school will accommodate 1100 pupils.

HubCo Design, Build, Finance and Manage (DBFM) procurement for the secondary element is mandatory as part of the funding terms and conditions.

# **Sources of Funding**

£15.333m of funding will be provided through a Scottish Futures Trust (SFT) grant and £8.667m will be provided through the ECS Composite Capital Programme.

## **Progress Update**

Discussions have begun with the developers of Bertha Park on the location and size of the site. The proposed site is 10 hectares.

The proposal paper for the Statutory Consultation to consult on the location and catchment area for the new secondary school was approved by a Special Meeting of Lifelong Learning Committee on 25 June 2014. The consultation period commenced on 11 September 2014 and completed on 19 November 2014. The final report to Lifelong Learning Committee will be considered no earlier than May 2015.

The New Project Request (NPR) was submitted to HubCo in June 2014.

# **Current Issues**

#### Overview

The SFT will provide 2/3rds of like for like funding towards the project, however this has not been quantified as yet.

# EARLY LEARNING AND CHILDCARE – 600 HOURS AND TWO YEAR OLDS ACCOMMODATION

Reporting Period: December 2014 to February 2015

#### Overview

A review of the suitability of nursery accommodation to deliver the Early Learning and Childcare requirements of the Children and Young People (Scotland) Act 2014 has been progressed. These requirements include free early learning and childcare provision for two year olds where a parent or carer is in receipt of certain benefits, looked after two year olds and increasing the hours of provision for 3-4 year olds to 600 hours per annum. These services were in place from August 2014.

In Perth and Kinross there are expected to be 175 eligible 2 year olds, with uptake estimated<sup>4</sup> incrementally at 125 children.

Phase 1 works are complete with 11 schools being modified to accommodate the provision of two year olds. These are: Balhousie Primary, Community School of Auchterarder, Coupar Angus Primary, Inchture Primary, Inch View Primary, Milnathort Primary, North Muirton Primary, Rattray Primary, St. Dominic's Primary, Stanley Primary and Pitlochry High School (Primary).

Phase 2 works are currently being planned and premises have been identified to further extend provision for two year olds which will minimise transitions and provide consistency of support for children and families. Feasibility studies are currently being considered at:

- Breadalbane Academy (Primary);
- Goodlyburn Primary;
- Kinross Primary;
- · Letham Primary;
- Methven Primary;
- Newhill Primary;
- St. John's Academy (Primary).

Provision at Alyth Primary and Errol Primary will be incorporated into the new school/upgrade builds as they are being progressed. Work will require to be done at the new Crieff and Oakbank builds after the initial snagging work is complete to plan for accommodating two year old provision in each.

#### **ERROL PRIMARY SCHOOL**

Reporting Period: December 2014 to February 2015

#### Overview

Following a recent feasibility study, design development work is currently being undertaken to address capacity issues. Land was previously procured adjacent to the school in March 2011 in order to facilitate expansion. Demolition and decontamination works were concluded on the additional land in 2012.

The scope of the works will provide 3 additional classrooms and ASN specialist provision together with associated ancillary space. The project will also include scope for a further 2 classrooms to be added to the building in the future should the need arise. The 2 additional classrooms are not likely to be required in the short to medium term, ie in the next 10 years.

It is intended that the new ASN specialist provision will occupy the current nursery space with a new larger space created for the nursery.

# **Sources of Funding**

This project will be primarily funded by the ECS Composite Capital Programme, with a virement from the Modernising Primaries Programme and from the Enhance/Extend Specialist Education Provision in Perth and Kinross budget. Developer Contributions will also be applied to this project. The current projected cost of the project is £3.317m.

# **Progress Update**

The Statutory consultation for the specialist provision for Additional Support Needs was undertaken between 7 January 2015 and 27 February 2015. Final approval will be sought from the Lifelong Learning Committee once the statutory process has concluded.

As the design work is progressing, the programme has been revised and is currently projecting completion in August 2016.

#### **EXTENSION TO THE ENTITLEMENT OF FREE SCHOOL MEALS**

Reporting Period: December 2014 to February 2015

#### Overview

On 7 January 2014, the Scottish Government announced all P1-P3 pupils will be eligible to receive free school meals (FSM) from January 2015.

Following this announcement, COSLA have been representing Local Authority interests with the Scottish Government with regards to the funding available, and whether this is sufficient to address the practical issues that have been identified.

Education and Children's Services, in partnership with Tayside Contracts, has identified some 1800 additional meals will be required daily over and above the current provision of approximately 8500 meals daily (all schools). This will take annual school meals provision for Perth & Kinross to approximately 2 million. There is capital investment required to enable 10 school kitchens to have the increased production capacity required to support the anticipated increased demand for meals across Perth & Kinross.

# **Sources of Funding**

On 17 July 2014, The Scottish Government announced revenue funding of £16.5m (£486k for Perth & Kinross) in 2014-15 and £54m (£1.591m for Perth & Kinross) in 2015-16.

This funding will cover additional supervisory costs and preparation costs.

## **Progress Update**

Progress has gone according to plan and the extended service is being delivered as expected.

#### PERTH ACADEMY - SPORTS HALL

#### PERTH GRAMMAR SCHOOL - INFRASTRUCTURE AND PRACTICAL UPGRADES

Reporting Period: December 2014 to February 2015

#### Overview

Perth Grammar School was selected for major infrastructure improvement as well as upgrade of its practical classrooms (6 CDT, 3 Science and 2 Home Economics) over the next three financial years. This project will be delivered through the new framework with Morrison Construction.

It is proposed to link the major infrastructure upgrade work with the practical classroom upgrades in an effort to minimise the potentially disruptive effect on the delivery of the pupils' education. The infrastructure works include electrical and data rewiring and upgrading, alarm and emergency systems renewal, heating systems renewal, energy conservation and other infrastructure and systems efficiency improvements.

# **Sources of Funding**

This project is being funded by ECS Composite Capital Programme to a value of £3,500,000.

# **Progress Update**

The Gross Maximum Cost (GMC) offer was received on 20 June and has been accepted. Works started on 27 June to refurbish the Craft, Design and Technology (CDT) classrooms and upgrade significant infrastructure within the school including major heating and electrical works.

The upgrade works associated with the zones identified as part of GMC1 was completed in October 2014.

Costs associated with the zones identified as part of GMC2 were submitted by the end of October 2014 and work is progressing to develop this phase of works. GMC2 works comprises upgrade of a Home Economics practical teaching area and continued infrastructure upgrade.

# **Progress Update**

Property has appointed external consultants to take forward the project, although it will still continue to be managed by Perth and Kinross Council architects.

On 7 October 2014, the Gross Maximum Cost (GMC) for works to form the new sports hall at Perth High School was formally accepted. The GMC is within the budget allocated. Work commenced on site in late October 2014 and completion is expected in December 2015.
