# **Pre-Application Report by Development Quality Manager**

Development of an unground barite mine with minehead surface infrastructure and mine portal at Duntanlich. Change of use of ferry cottage to office premises at Ferry House, Logierait, Pitlochry

Ref. No: 15/00001/PAN Ward No: N4 - Highland

# Summary

This report is to inform the Committee of a forthcoming planning application in respect of a major development for a proposed Barite mine with associated infrastructure on land at Duntanlich by Logierait, Pitlochry.

#### **BACKGROUND AND DESCRIPTION**

- In accordance with the provisions of the Town & Country Planning (Scotland)
  Act 1997 as amended, the applicants submitted a Proposal of Application
  Notice on 08 January 2015. The purpose of this report is to inform the
  Development Management Committee of a forthcoming planning application in
  respect of a major development on Land at Duntanlich. Pre-application reports
  give the Committee an opportunity to raise issues which it would like to see
  addressed in the planning application.
- Access to the site would be taken from the A827 between Ballinluig and Logierait at Ferry Cottage which is proposed to be used as the site office. A new access track 0.93km in length would be formed to the edge Logierait Woods. Within Logierait Woods/Killiechangie Woodland and Fonab Forest there is 8.85km of proposed track, mostly utilising existing forestry tracks and forest rides. From Fonab Forest there would be 5.2km of access track across the moor to the mine site.
- The mine site area is 1.2 hectares in total consisting of excavated hillslope, landscaped mound and mine platform, of which 0.62 hectares is the mine site platform operational area. A temporary laydown area for construction materials of 0.5 hectares is likely to be required adjacent to the access track at the mine site. This area, consisting of an excavated hillside slope and the landscaped mound is to be immediately restored as part of the final construction phase. The transfer site located in the forestry has an area of 0.37 hectares. Borrow pit extraction and stockpile areas are proposed and total 3.0 hectares.
- The barite resource identified from drilling is estimated to be some 7.5 million tonnes. A 50 year life for the mine development is proposed, with annual production of 120,000 tonnes.

Transport of the barite ore from the minesite to the transfer site will be by articulated truck, as currently undertaken at Foss Mine. Three trucks will be utilised, each truck undertaking 4 return journeys daily between the mine site and transfer site. Road haulage trucks will transport processed barite to M-I SWACO operations in Aberdeen via the A827, the A9 and the A90. Seventeen loaded vehicles will be despatched daily, three of which will be routed to Perth Harbour around the southern side of the city.

#### **PRE-APPLICATION PROCESS**

- The Proposal of Application Notice (reference 15/00001/PAN) outlined that public exhibitions will be held on the 17 February 2015 at the Mid Atholl Hall in Ballinluig, the 19 of February 2015 at the Town Hall in Aberfeldy and the 25 February 2015 at the Fisher's Hotel in Pitlochry.
- The Aberfeldy Community Council, Mid Atholl, Strathtay and Grandtully Community Council, Pitlochry and Moulin Community Council as well as Dull and Weem Community Council have received a copy of the Proposal of Application Notice. The results of the community consultation will be incorporated into a Pre-application Consultation report and will be submitted as part of the application.

#### NATIONAL POLICY AND GUIDANCE

# **National Planning Framework**




