Summary

This report is to inform the Committee of a forthcoming planning application in respect of a major development between Tullymurdoch Wind Farm to substation at Coupar Angus consisting of the installation of an underground electricity cable.

BACKGROUND AND DESCRIPTION

- In accordance with the provisions of the Town & Country Planning (Scotland)
 Act 1997 as amended, the applicants submitted a Proposal of Application
 Notice on 10 June 2015. The purpose of this report is to inform the
 Development Management Committee of a forthcoming planning application in
 respect of a major development on land between Tullymurdoch Wind Farm to
 substation at Coupar Angus for the installation of an underground electricity
 cable. Pre-application reports give the Committee an opportunity to raise issues
 which it would like to see addressed in the planning application.
- It is proposed to construct an underground electricity cable from the consented Tullymurdoch wind farm via the consented Welton of Creuchies windfarm to a substation located at Coupar Angus. The route is approximately 19km in length, the cable trench would be 1m in width and the temporary working corridor would be approximately 150m at the widest points.

PRE-APPLICATION PROCESS

- The Proposal of Application Notice (reference 15/000012/PAN) outlined that a public exhibition would be held on 28 July 2015 as a key part of the community consultation process. A copy of the Proposal of Application Notice has also been sent to the Alyth Community Council, Blairgowrie and Rattray Community Council, Coupar Angus and Bendochy Community Council and the Kirriemuir Landward West Community Council.
- The Planning Authority on receipt of the PAN confirmed that further consultation activity should be undertaken. This included a request that consultation and a formal invite to the public event are extended to include the Alyth Development Trust, Coupar Angus Regeneration Trust along with the following ward councillors Bob Ellis, Liz Grant, Caroline Shiers, Alan Grant, Dennis Melloy, Ian Miller and Lewis Simpson.

5 The results of the community consultation will be incorporated into a Preapplication Consultation report and will be submitted as part of the application.

NATIONAL POLICY AND GUIDANCE

PLANNING SITE HISTORY

17 12/01423/FLL - Formation of wind farm with associated access track and ancillary works at Tullymurdoch by Alyth. The application was refused by the Development Management Committee but subsequently allowed on appeal.

10/00876/FLL - Erection of four wind turbines, access road and associated infrastructure at Welton Of Creuchies by Alyth. The application was refused under delegated powers but was subsequently allowed by the Local Review Body.

ADDITIONAL STATEMENTS WHICH WILL BE REQUIRED

- In order to support the planning application, unless an EIA is required, the following supporting documents should be submitted:-

 - Pre-Application Consultation Report
 - Archaeology Statement (proximity to scheduled ancient monument)
 - Landscape Assessment/statement and Landscaping Schedule
 - Noise Assessment
 - Construction Management Plan (CMP) (pollution sediment runoff to River Tay Special Area of Conservation).
