# School Estate Capital Programme Progress Update

# **Report by Executive Director (Education and Children's Services)**

# PURPOSE OF REPORT

This report updates Committee on the progress and proposals for delivering the current school projects within the Education and Children's Services Capital Programme. It details key milestones which have been achieved since the last update to Committee on 4 June 2015 (<u>Report No. 15/246 refers</u>).

# 1. BACKGROUND/MAIN ISSUES

- 1.1 The School Estate Strategy sets out the Council's aspirations for our schools, and in particular the high value we place on learning, through our vision for well designed, maintained and managed schools.
- 1.2 The strategy is delivered through the School Estate Management Plan (SEMP) which is primarily funded through the Council Capital Programme.
- 1.3 The Education and Children's Services (ECS) Capital Programme details the priorities for the School Estate over a rolling seven year period, and is reviewed on an annual basis.

# 2. PROPOSALS

- 2.1 This report updates Committee on progress and proposals for delivering the current capital projects within Education and Children's Services School Estate Programme. The focus of the programme is on:
  - Primary School Upgrades
  - Secondary School Upgrades
  - Design, Build, Finance & Manage (DBFM) Projects

# 3. UPDATES ON CURRENT PROGRAMME

3.1 Detailed updates on all current projects are provided in Appendix A. The following projects have reached significant milestones since the previous School Estate Sub-Committee on 4 June 2015.

# Significant Milestones – Primary School Upgrade Programme

# 3.2 Alyth Primary School

Works in the 1960's block were completed over the summer holidays to allow all staff, pupils and community users to be accommodated while the new building is constructed.

## 3.3 Crieff Primary School

The new school project was completed in June 2015 as planned and the school became operational on 17 August 2015.

## 3.4 Errol Primary School

Work started on site on 6 July 2015 as planned. The scope of the project will provide 3 additional classrooms, increased nursery provision and specialist provision for Additional Support Needs, together with associated ancillary space.

On 26 August 2015, the meeting of the Lifelong Learning Committee considered the final report in relation to the statutory consultation for the specialist provision for Additional Support Needs.

## 3.5 Oakbank Primary School

The works to complete the new school building were completed in June 2015 as planned and the school moved into the new building prior to the school summer holidays. Works are continuing on site to form outdoor areas after the demolition of the old school.

On 26 August 2015, the meeting of the Lifelong Learning Committee considered the final report in relation to the statutory consultation for the specialist provision for Additional Support Needs.

# Significant Milestones – Secondary School Upgrade Programme

## 3.6 **Perth Grammar School**

Work was completed in August 2015 for the current phase of the funded infrastructure and practical upgrade work at Perth Grammar School. The scope of the works included infrastructure upgrades and 14 spaces within Craft Design and Technology (CDT),Computing and Home Economics. Further investment is required and a Business Case will be submitted as part of the budget process.

# Significant Milestones – Design, Build, Finance and Manage (DBFM) Programme

3.7 The DBFM projects (New Secondary School, Kinross Primary School and Tulloch Primary School) are consolidated under a single programme in line with revenue funding arrangements set out by the Scottish Futures Trust (SFT).

The pre-New Project Request (NPR) Key Stage Review, which is an important Scottish Futures Trust milestone, is complete for all three projects and the NPR was issued to HubCo in June 2015 and accepted at the beginning of July 2015 for the programme.

# 3.8 New Secondary School

The Statutory Consultation period for the new Secondary School ended on 15 July 2015.

# 4 FUNDING OPPORTUNITIES

- 4.1 In August 2014, the Scottish Government announced £5m funding to create innovative learning environments. This funding will support the redesign of internal learning environments which will enable senior pupils to have early access to vocational qualifications.
- 4.2 The Council has bid for funding towards creating a 'Vocational Engineering Hub' which would be used to develop an engineering facility at one of the city secondary schools. This proposal will allow Perth and Kinross to offer courses and develop a vocational pathway in engineering for senior pupils in Perth City Campus secondary schools.
- 4.3 The Scottish Futures Trust has advised that submissions have been put forward to the Scottish Government and an announcement will be made at the end of August 2015.

# 5. CONCLUSION AND RECOMMENDATIONS

- 5.1 This report updates School Estate Sub-Committee on progress of the Education and Children's Services School Estate capital projects approved through the Capital Programme for 2015/16 to 2021/22.

- Acceptance of the New Project Request (NPR) for the New Secondary School, Kinross Primary School and Tulloch Primary School by HubCo; (3.7) and
- The Statutory Consultation period ending for the New Secondary School (3.8).
- 5.3 Committee is also asked to note the following:
  - The opportunity for funding towards creation of a 'Vocational Engineering Hub' for the Perth City Campus.

# 2. Resource Implications

<u>Financial</u>

- 2.1 The Council set a 7 year Capital Budget for 2014/15 to 2020/21 at its meeting on 13 February 2014 (report 14/45 refers). Revisions to the budget for these 7 years have been considered by the Strategic Policy and Resources Committee throughout the year. The meeting of the Council on 12 February 2015 approved the Composite Capital Budget 2015/23 (report 15/37 refers). Additional capital funding has been received from the Scottish Government for the implementation of capital works associated with the Children and Young People (Scotland) Act 2014.
- 2.1.1 Any additional revenue implications identified through either the existing capital programme, or future capital programmes, with the exception of the new secondary school, will require be submitted as part of an expenditure pressure with a corresponding saving through the ECS revenue budget process.
- 2.1.2 There are no direct financial implications arising from this report other than those reported within the body of the main report and related business cases.

The purpose of the URG is to assist with providing relevant local input to allow the Design Team to develop the outline concept design into an operational design. The formation of a URG is an invaluable source of information, and any project is reliant on this level of local detail.

## ALYTH PRIMARY SCHOOL

## Reporting Period: June 2015 to August 2015

## Overview

Alyth Primary School is a largely life-expired property requiring major investment. The school has been identified as having the highest maintenance requirement of any primary school in Perth and Kinross. It is also under-utilised and inefficient in terms of layout and running costs.

The recommended option to upgrade the Victorian building and add a new-build element was approved at Lifelong Learning Committee on 29 January 2014 (Report 14/22 refers). It is anticipated the new school will be operational in school session 2016/17.

## Sources of Funding

This project will be fully funded by the ECS Composite Capital Programme. The funding for this project is £8,982,000.

## Progress Update

The Stage 1 report has been analysed and was formally accepted on 19 February 2015. An informal drop-in session was held on 26 January 2015 where the design was shared with Parents/Carers and the wider school community. The concept design was shared with the User Reference Group on 11 December 2014 and was well received.

The planning application has been approved.

As part of the project delivery, the decant requirements are all being met using areas of the existing school, with the exception of some additional toilet accommodation within the community area. The school have started the process of packing and rationalising resources in advance of decant after the summer holidays.

The programme is noted as challenging to meet as it has very little flexibility. Further consideration of the programme dates and discussions are ongoing in this regard.

## **CRIEFF PRIMARY SCHOOL**

## Reporting Period: June 2015 to August 2015

### Overview

Following the outcome of a statutory consultation exercise, Lifelong Learning Committee approved that education provision at the existing Crieff Primary School is relocated to a new school on the site adjacent to Strathearn Community Campus from August 2015 (<u>report 12/486 refers</u>). The school will initially comprise of 15 classes with the infrastructure and capacity to increase to a triple stream in the future if required.

Along with Oakbank Primary School, this school is being procured and developed through a HubCo Design & Build Development Agreement (DBDA).

## Sources of Funding

This project is being fully funded by the ECS Composite Capital Programme. The total project budget is £11.806m including land purchase.

## **Progress Update**

Enabling works began on the site of the new primary school in Crieff on 24 March 2014. Financial Close was achieved on the project on 9 May 2014 and the main contractual works began thereafter. The project completed in June 2015 and the new school is now operational. (August 2015).

The pavement at the junction of Duchlage Road to Broich Road has been widened and the remaining footpath has been resurfaced. There are now lamp posts along Broich Road and 20's plenty signs have been installed. The school will continue to focus on the travel plan and working on safer routes to school.

Tesco have confirmed they will no longer be building the supermarket adjacent to the school on Broich Road. Aldi are due to put forward proposals for the development of the site and The Environment Service will seek to continue discussions about a possible footpath as part of the development.

## DESIGN, BUILD, FINANCE AND MANAGE (DBFM) PROGRAMME -NEW SECONDARY SCHOOL

## Reporting Period: June 2015 to August 2015

## Overview

A review of the School Estate has taken place to determine the likely impact of anticipated population growth on the school estate in the medium to long term. One of the priorities for the Council has been agreed as a secondary school on the northern perimeter of Perth. The school will accommodate 1100 pupils.

HubCo Design, Build, Finance and Manage (DBFM) procurement for the secondary element is mandatory as part of the funding terms and conditions.

## Sources of Funding

Full funding will be provided through the Scottish Futures Trust (SFT).

## **Progress Update**

The Scottish Futures Trust pre-New Project Request Key Stage Review is complete and the NPR was issued to HubCo in June 2015 and accepted at the beginning of July 2015.

The procurement process is complete and Robertson Construction has been selected as the Tier 1 Consultants (Main Contractor). The Tier 2 Consultants selected comprise, Archial Norr (Architects), Wallace Whittle (Mechanical & Electrical) and Goodsons (Civil & Structural).

The above milestones are an indicative HubCo Programme and will require to be confirmed.

# **Current Issues**

- It should be noted that an area of land is still to be secured and this is a risk to the project.
- There is a heavy dependence on having infrastructure in place, in particular the utilities, which is linked to planning permission for the project.
- Any delay in the completion of the Almond Crossing and the link road will impact on the programme
- Revenue funding for this project will be required. This funding has been identified as a pressure in the medium term financial plan approved by Council on 8 October 2014 (Report 14/433 refers). Corresponding savings will be required to cover this pressure.

# EARLY LEARNING AND CHILDCARE – INCREASE FROM 475 TO 600 HOURS AND TWO YEAR OLDS

## Reporting Period: June 2015 to August 2015

## Overview

A review of the suitability of nursery accommodation to deliver the Early Learning and Childcare requirements of the Children and Young People (Scotland) Act 2014 has been progressed. These requirements include free early learning and childcare provision for two year olds where a parent or carer is in receipt of certain benefits, looked after two year olds and increasing the hours of provision for 3-4 year olds to 600 hours per annum. These services were in place from August 2014.

A progress report providing a further update on the programme was submitted to the meeting of the Lifelong Learning Committee on 27 May 2015 (Report No. 15/214 refers).

Phase 1 works were completed by August 2014, with 11 schools being modified to accommodate the provision of two year olds.

Provision at Alyth Primary and Errol Primary will be incorporated into the new school/upgrade builds as they are being progressed.

## ERROL PRIMARY SCHOOL

## Reporting Period: June 2015 to August 2015

### Overview

This project is currently being taken forward to address capacity issues at Errol Primary School. Land was previously procured adjacent to the school in March 2011 in order to facilitate expansion. Demolition works were concluded on the additional land in 2012.

The scope of the works will provide 3 additional classrooms, increased nursery provision and specialist provision for Additional Support Needs (ASN) together with associated ancillary space. The project will also include scope for a further 2 classrooms and a small hall to be added to the building in the future should the need arise. The 2 additional classrooms and hall are not likely to be required in the short to medium term, ie in the next 10 years.

The new ASN specialist provision will occupy the current nursery space with a new larger space created for the nursery.

#### **Sources of Funding**

This project will be funded by the ECS Composite Capital Programme and Developer Contributions. The current project budget is £3.317m.

## **Progress Update**

On 26 August 2015, the meeting of the Lifelong Learning Committee considered the final report in relation to the statutory consultation for the specialist provision for Additional Support Needs.

On 25 February 2015 planning permission was granted for the project. Listed building consent was granted on 19 March 2015. Work started on site on 6 July 2015 as planned.

## **Current Issues**

It should be noted that the new ASN facilities will not be complete until September 2016, as this involves work on the nursery which cannot commence until summer 2016. ASN provision will be available from August 2016, in an alternative location in the school.

## **INCHTURE PRIMARY SCHOOL**

## Reporting Period: June 2015 to August 2015

## Overview

The works to extend Inchture Primary School by 2 additional classrooms, a General Purpose (GP) room, extending the school learning resource library and a hall to deliver the primary school PE curriculum was completed in October 2014. Project design work is ongoing in relation to the Multi Use Games Area (MUGA).

## Sources of Funding

This project is funded by the ECS Composite Capital Programme and Developer Contributions. The overall budget for this project is £2,838,000. The Education & Children's Services contribution to the MUGA element of the project remains at £75,000 (excluding contingencies of £19,000). The community are contributing £112,000 to the MUGA for construction and ongoing maintenance.

## **Progress Update**

The classroom element of the work was completed in August 2014 in time for the start of the new school term as planned. The works to the sports hall were completed in November 2014.

A meeting was held with the Community in December 2014 with regard to outdoor sports facilities. Discussions regarding the MUGA specifications are ongoing with the community to identity an affordable design. In addition, the programme is currently being reviewed to take account of this. It should be noted that the synthetic turf cannot be laid during the winter months and the programme will need to reflect this.

After allowing for contingencies, savings within the overall budget have been delivered.

## Reporting Period: June 2015 to August 2015

## Overview

The infrastructure works include electrical and data rewiring and upgrading, alarm and emergency systems renewal, heating systems renewal, energy conservation and other infrastructure and systems efficiency improvements.

This project is being funded by ECS Composite Capital Programme to a value of £3,500,000.

On 7 October 2014, the Gross Maximum Cost (GMC) for works to form the new sports hall at Perth High School was formally accepted. The GMC is within the budget allocated. Work commenced on site in late October 2014 and completion is expected in December 2015.

Discussions are ongoing to agree the terms of the management of the hall once it is operational.
