2015/16 FINANCIAL STATEMENT

Joint Report by Head of Finance & Director (Environment)

PURPOSE OF REPORT

This report details Income and Expenditure to 20 November 2015 and the projected outturn to 31 March 2016 for the Crieff Common Good Fund.

1. BACKGROUND / MAIN ISSUES

1.1 The Committee approved the budget at the meeting of the 13 May 2015. This report provides the monitoring position and projected outturn for the Financial Year 2015/16.

2. PROPOSALS

2.1 Financial Statement 2015/16

On the basis of Appendix 1, it is anticipated that a surplus of £650 will be generated in 2015/16 and that the Fund's estimated Revenue Account Balance will be £7,729 at 31 March 2016. The movement from the projected closing balance of £6,921 reported to this Committee on 7 October 2015 (Report No 15/426 refers) mainly relates to the deferral of the financial assistance applications considered at the October meeting. In addition there has been a restatement of the 1 April 2015 opening Revenue Account balance following closure of the 2014/15 accounts.

3. CONCLUSION AND RECOMMENDATION

3.1 The Committee is requested to note the Crieff Common Good Fund Income and Expenditure to 20 November 2015 and the projected outturn to 31 March 2016.
