715. UPDATE REPORT ON KINSHIP CARE

There was submitted a report by the Director (Social Work) (15/509) (1) informing the committee of the current position in relation to Approved Kinship Carers, outlining developments in national policy and raised expectations in relation to the financial support for looked after children and young people in kinship care and (2) providing an update on the impact of the decision to remove the provision of financial allowances to informal Kinship Carers.

- (iv) A revised Kinship and Fostering Allowances Policy be approved for publication by January 2016.

716. CHILDREN AND YOUNG PEOPLE (SCOTLAND) ACT 2014: FINANCIAL ARRANGEMENTS TO SUPPORT THE IMPLEMENTATION OF CONTINUING CARE (PART 11)

There was submitted a report by the Director (Social Work) (15/510) setting out detailed financial implications of continuing care under Part 11 of the Children and Young People (Scotland) Act 2014 and the proposals for funding continuing care placements. It was noted the report should have stated up to £420 in paragraph 2.4.

Resolved:

- (iv) It be noted that individual negotiation would take place with the providers of external placements in order to assist young people to exercise their right to choose continuing care.

will take on the roles and responsibilities of Named Persons and Lead Professionals from August 2016 as part of the new duties under the Children and Young People (Scotland) Act 2014.
