#### **Instrumental Music Service Review**

Prior to the commencement of business the Convener advised that since completion of the review of the Instrumental Music Service (IMS) the Council had received its financial settlement from Scottish Government. As the Council will set the overall budget for the coming financial year on 11 February 2016 it would be wrong to consider options for making the Council approved saving of £75,000 in isolation of what may or may not come of the Council's budget deliberations. The Council's commitment to the service remains despite the financial challenges faced, however, the Council can and must look at new ways to sustain and secure the service for the future. The detailed IMS review recommendations will set out the basis for how the Council achieve that over the course of 2016/17. In the meantime, dialogue with parents' groups and others who have a key stake in IMS will continue.
