

PERTH AND KINROSS COUNCIL**Auchterarder Common Good Fund Committee****18 May 2016****Applications for Financial Assistance****Report by Director (Environment)**

The report asks Auchterarder Common Good Fund Committee to consider 1 application for financial assistance.

1. BACKGROUND

- 1.1 Perth and Kinross Council owns land and property which forms part of the common good of the former burghs in Perth & Kinross and has a statutory duty in terms of section 15 of the Local Government etc. (Scotland) Act 1994 to administer this land and property “having regard to the interests of the inhabitants” of those former burghs. This duty also applies to the administration of the associated common good funds.
- 1.2 The Common Good Funds have traditionally demonstrated their support to local residents and organisations by distributing grant. These grant awards allow individuals and local organisations to carry out a wide range of community based activities. For each application, the level of previous grant awarded is listed, but variances between years could be due to the numbers of participants. Retrospective applications are not accepted. However, if an application is received before the activities take place and cannot be considered at the following meeting because the papers have already been issued, the application will be considered at the next meeting even if the activities have taken place between meetings. Therefore, the Committee decision will only be known after the activities have taken place, and if the grant is not awarded, the applicant will have to fund the activities from its own funds.

2. PROPOSAL**Auchterarder Community Sports Association**

- 2.1 An application has been received from Auchterarder Community Sports Association seeking a grant towards the cost of Auchterarder Core Path Project Phase 1 and Phase 2. Phase 1 includes different paths in Auchterarder Town Centre: Avenue Path, Oak Walk, Common Loan, Johnny Mathies, Black Road and East Hill Link. The total costs of the phase 1 are £316,799 (construction, contingency, VAT and project management). Phase 2 aims to improve Provost Walk. The total costs for Phase 2 are £800,000. The applicant has secured £100,000 from the West Perthshire Recreational Facility, has applied to Auchterarder and District Community Trust for £100,000 and Sustrans for £535,843. There is therefore a shortfall of £380,956 to meet costs for Phase 1 and Phase 2.

The applicant has applied for £100,000 from Auchterarder Common Good Fund leaving a funding shortfall of £280,956 which would have to be funded from other funding sources not specified in the application form. The applicant has never previously benefited from the fund.

- 2.2 The proposal meets the criteria of the provision of community benefit for the people (including any individual or group of people) who live in the former burgh served by Auchterarder Common Good Fund Committee.
- 2.3 A separate report containing 2016/17 budget proposals for the Auchterarder Common Good Fund will be considered by Committee at this meeting. The projected uncommitted Revenue balance for the Fund at 1 April 2016 is £358,809, and the estimated income to be generated from rents and investments in 2016/17 is approximately £23,500.

Recommendation

- 2.4 In line with revised guidance, the Committee is asked to consider the request and no recommendation is made by Officers. The Committee may consider awarding funding subject to all funding being in place.

3. RECOMMENDATION

- 3.1 The Committee is requested to consider the request in the report.
