**FLOOD RISK MANAGEMENT (SCOTLAND) ACT 2009
COMRIE FLOOD PROTECTION SCHEME 2020**

In accordance with Section 60 and Schedule 2 of the above legislation Perth and Kinross Council proposes the above flood protection scheme.

The scheme involves the following:

- Flood defence walls
- Flood defence embankments
- Erosion protection measures (grey and green bank protection)
- Utility and service diversions
- Hard and soft landscaping features
- Road works
- Accommodation works

The Scheme will reduce the risk of flooding to 189 properties across Comrie up to the predicted 1 in 200 year flood on the above noted bodies of water

Perth and Kinross Council is required to serve a statutory notice upon you with regard to the Scheme under the terms of the relevant legislation. A copy of this notice is attached.

The notice will be published on 28 February 2020 and within a period of 28 days from that date, any person may object to the scheme as outlined in the attached notice.

The attached notice states the scheme documents can be inspected without payment of fee at Perth and Kinross Council, Pullar House, 35 Kinnoull Street, Perth, PH1 5GD, during the hours of 8.45a.m. to 5.00p.m, Monday to Friday inclusive, except 8.45am to 11am on the first Thursday of every month, from 28 February 2020 until the date a decision regarding the Scheme is made under paragraph 4(1), 7(4) or, as the case may be, 9(1) of the Act.

The scheme documents will also be made available for inspection online (<https://www.pkc.gov.uk/article/21568/Comrie-flood-protection-scheme-documents>) and at the Comrie Public Library for the same period of time. Opening hours for the Library are between hours of 2.00 pm to 4.30 pm and 6.00 pm to 8.00 pm on a Thursday, 10.00 am to 12.30 am on a Friday, and 09.30 am to 12.30 am on a Saturday.

Please note that the Library will be an unmanned viewing location and technical support will only be available at the Council office or via the contact details shown above.
