1	Welcome and Apologies	
	BA welcomed all to the meeting and apologies were noted as above.	
2	Minute of Meeting of the Adult Protection Committee (05.03.2021)	
	An overview of the previous Adult Protection Committee minute was provided and an update on any actions taken.	
3	Minute of Meeting of the Adult Protection Sub-Committee (22.04.2021)	
	An overview of the previous Sub Committee minute was provided, and comments or questions welcomed.	
4	Scottish Ambulance Services – Jayne Scaiffe	
	JS provided a presentation detailing the enhanced commitment and capacity to Public Protection and Adult Protection in particular within the Scottish Ambulance Service.	
	MN was aware that there was confusion on who to contact when providing a referral and wondered if this has been clarified. JS agreed one of the initial issues was that people didn't know who to contact which within the pandemic changed regularly, therefore the introduction of a single point of contact allows them to access what they require faster, freeing them to move onto the next person in need. However, communicating this has been slow and not all crews are aware of the single point of contact.	
	MN feels there is a misunderstanding that if the hospital is informed they will let social work know which isn't always the case. JS is aware of this issue, in 2018-19 there were 360 referrals but 4500 safeguarding records on EPRF, so a big mismatch which we hope to combat with eLearning and face to face training.	
	GG is the co-chair of the national ASP NHS group and welcomed JS's new adult protection leads to join that network.	

	GG said that that following an SCR, a lot of work is being completed around the challenges we hold in sharing information due to the different systems used. Within the SCR it highlighted that there is information available that other services need to be able to view. GG asked if this would be helpful or if there are other systems from another board that would be beneficial to use. JS said that the ambulance service is very isolated with the information that is shared with them and thinks that it would be great if there could be a way to share information throughout the whole of Scotland.	
5	COVID on Care Homes – Lynn Blair	
	LB provided a presentation on the Impact of Covid 19 on Care Homes and comments were welcomed.	
	JW thanked LB for the presentation, which brought about emotion on how hard it has been on us all. There has been so much support from LB, Zoe and Dave and their team with the weekly meetings, we wouldn't have got through without them, where information was provided that otherwise we wouldn't have been aware of, along with providing feedback when needed. JW reiterated how hard it was on the staff and residents and that it is still ongoing but thanked JW for the support provided.	
	JP said that LB gave an excellent account of how challenging and relentless the last year has been. It has been really difficult, even just the data being provided on more than a daily basis, it has been quite outstanding that people have managed to respond to those challenges and care for the residents at the same time.	
	JP said that the scrutiny of the care home sector has been stepped up exponentially, and we wanted to make sure that that scrutiny being asked of us was done in a supportive way, so that it was about reaching out and being on the journey with people and it is good to hear that was the experience on a whole. JP confirmed the local oversight and weekly oversight meetings will continue for at least another year, until March 2022. JP recognises that the public confidence in the sector has been damaged by some of the material that has been around and the recovery from that will be another journey taken together.	
	JP wanted to recognise the statutory responsibility to review residents placed by partnerships on behalf of PKC remains in place, and there was a request for all residents to be reviewed by social workers within a specified period which PKC met.	
	SH imagines there is a range of views of the requirements for staff to be vaccinated. And wondered if there is an emerging trend. LB said that the	

	uptake for staff in PKC has been really high. We have a few members of staff that have not wanted it, which is their choice. There are some providers that do want to make it mandatory, and there are national conversations being carried out on if they are able to do that. SM thanked LB for her presentation and asked if there has been any learning taken from the last year. LB said there has been lots of learning such joint working and strengthening people's resilient plans, the past year has made emergency plans much more robust in ways of staffing and also barriers in working together in the independent sector has been broken down. LB feels that the building and planning of Care Home size will also need to consider the risk associated as less than of 20 beds is 5% chance of getting Covid, however if you have 80+ beds you have 80-100% chance. We also have older buildings, which have not been built with infection, prevention, and control in mind, where they are easily separated and buildings going forward should also consider this.

7	NHS update – Grace Gilling	
	GG provided a summary of the first NHS Adult Protection Annual report and welcomed any feedback.	
	NHS Tayside has set up a short life working group to look at internal processes and capacity for ensuring we are able to access medical records which will feed into the multiagency discussions.	
	There have been 2 short life working group meetings carried out so far, and from a Perth and Kinross perspective, Dr Humble, GP and IW, ASP Coordinator, are within this group. The meetings are looking at developing capacity assessment pathways to support assessments, it is building on work completed by NHS Grampian, which is progressing very well. A draft pathway will hopefully be presented within the next ASP Committee.	GG
	Following the publication of Trust and Respect last February, there was an opportunity at the end of March, which BI circulated, to provide an update and feedback to the Mental Health Strategy team on the progress of the 51 recommendations. This is currently being worked on, but no date has been provided on when this will be shared.	
	IW spoke with chair of the Mental Health Strategy who is keen that IW remains part of that, and trying to dovetail Adult Protection, Public Protection,	

and Mental Health agendas where we can, so for the time being IW will continue to attend.
