1	Welcome, Introduction and Apologies

2	Minutes of Previous Meeting, Action Points and Matters Arising		
	 The Minute of 25 October 2022 was approved as an accurate record. Action Points 2 to 7 and 9 – Completed / Agenda Items. Action 1: Bill Atkinson / Hazel Robertson / Sharon Johnston / Elaine Cruickshank / Ray Birnie / John Cunningham / Ross Drummond to complete their discussions in relation to the increase in demand on services / agencies and report back to the next meeting of the CPC on 6 December 2022 – Members noted the group met and agreed to focus on 2 particular areas, and whether there is anything we can do on a multi-agency basis whilst making best use of existing resources – the issue

	Action 9: Lesley Sharkey to have a discussion with the NHS Tayside Child Health Commissioner and confirm how the refreshed GIRFEC guidance is to be taken forward across Tayside – LS has had discussions within NHST and is due to meet with the NHST Children's Commissioner next week. LS is also meeting with HR / SJ / Sheena Devlin from a multi-agency perspective. Action Completed.		
	Action 10: Bill Atkinson to confirm via the Children, Young People & Families Partnership who is to be P&K GIRFEC Lead and how the refreshed GIRFEC guidance is to be taken forward across Perth and Kinross – Noted this was raised at the CYPFP, however the lead and how this will be progressed is still to be determined. Noted there is an action in the CPC Improvement Plan around a Tayside approach to GIRFEC – RB / BA / RD to raise this at TRIC PG5. Action Completed.

i)	PKC Exclusion Guidance for Schools and ELC – Members noted the Exclusion Guidance, which was updated as a result of a number of changes nationally e.g. The Promise and Additional Support for Learning (ASL) Act etc. Noted there is a greater need to work together around alternatives to exclusion for CYP with protective characteristics etc. Action Completed.		
3	CPC Restructuring and Priorities for 2023		
	Members noted the proposal paper which is based on previous meetings / discussions. Noted there is some urgency for the CPC Inter-Agency Guidelines to be refreshed, progressing actions in the CPC Improvement Plan and looking at other approaches to learning from LRs etc.		
	CPC Quality Assurance Working Group – Noted there is an evidence base to re- establish the QA group; BA / RD will approach members to join this small group; there is an offer from the Link Inspector etc; plan to get the group up and running in early 2023.		
	CPC PIWG – Chaired by HR; increasingly dominated by QA; need to look at refocussing this group back to practice improvements.		
	CPC CRWG – RB has just been appointed as the Chair and Graeme Templar as the Vice Chair.		
	BA / HR / RD are due to meet on 9 December 2022 and will review the membership of the CPC Sub Groups and finalise the proposal – members to return any feedback to RD by the end of the week.
