

Forth Estuary Local Flood Risk Management Plan



- Under the Flood Risk Management (Scotland) Act, Kinross has been identified as one of 235 'potentially vulnerable' areas of Scotland at significant risk of flooding.
- The Forth Estuary Flood Risk Management (FRM) Plan and Local FRM Plan were published in December 2021 and December 2022.
- The FRM Plan and Local FRM Plan direct the actions of SEPA and the responsible authorities (the Council and Scottish Water) with regards to their flood risk management activity over the 6 years from 2022 to 2028.

Forth Estuary Local Flood Risk Management Plan



- Flood protection scheme
- Maintain flood protection scheme (once built)
- Sewer flood risk assessment (Scottish Water)
 - Surface water management plan
 - Community engagement (Responsible Authorities)

Forth Estuary Local Flood Risk Management Plan

- Flood forecasting (SEPA);
- Awareness raising;
- Self-help measures;
- Maintenance (clearance and repair works);
 - Emergency plans/response;
- Managing flood risk through the application of development planning policy.

The Council will continue to act in accordance with the published FRM Plan and Local FRM Plan.









- A flood scheme is likely to be some time away.
- Whilst public bodies have certain duties to manage and, where achievable, reduce overall flood risk, the primary responsibility for avoiding or managing flood risk still remains with land and property owners.
 - The Forth Estuary Local FRM Plan therefore also includes actions which are intended to enable you and your community to take action and to become more resilient to flooding.

Flood Protection Scheme

A flood protection scheme is proposed for Kinross to manage the combined risk of flooding from the South Queich, Clash Burn and Gelly Burn.

Maintain Flood Protection Scheme

Once built, the Council will implement an inspection and maintenance regime for the Flood Protection Scheme.

Sewer Flood Risk Assessment

Scottish Water will undertake an assessment of sewer flood risk within the Kinross sewer catchment to improve their knowledge and understanding of sewer flood risk.

Surface Water Management Plan

The Council will develop a surface water management plan for Kinross to improve the understanding of surface water flood risk, and in the longer term look at possible action to manage the risk. The results of the sewer flood risk assessment will be considered.

Community Engagement

The responsible authorities will continue to engage with the community ongoing projects, including the proposed flood scheme and surface water management plan.

Kinross Flood Resilience Group

Perth & Kinross Council will continue to support this Group to raise awareness and to encourage the local community to become more prepared and resilient to deal with flooding in the future.

Action on Flooding

Flood Forecasting (SEPA)

SEPA will continue to issue the national flood guidance statement to the public and emergency responders.

Awareness Raising

- Improved awareness of flood risk and the actions that prepare individuals, homes and businesses for flooding can reduce the overall impact.
- The information provided at this public exhibition will raise awareness of flood risk in Kinross.

Action on Flooding

Self-Help - Property Flood Products

- As a householder or a business, you can install products to protect your property from flooding.
- Flood products, such as flood gates for doors and air brick covers, are widely available and are designed to suit a variety of homes.
- The Scottish Flood Forum can provide you with further advice on this, and also on any related flood insurance matters.

Action on Flooding

Maintenance - Clearance and Repair Works

- The Council has a duty to assess bodies of water and to carry out clearance works where this will **substantially** reduce flood risk.
- In relation to the South Queich, Gelly Burn and the Clash Burn, the Council undertakes routine inspections on a 6 monthly basis, although we will act if any issues are reported in the intervening period.
 - Riparian landowners are encouraged to keep their sections of the rivers clear and remove any obstructions that would reduce their flow capacity.
- The Council has and will continue to report issues to landowners and carry out clearance works as required.

Emergency Plans/Response

- The Council will also assist where possible during flood events by providing sandbags and pumps on a priority basis to residents where flooding is imminent.

Land Use Planning

The Council will continue to comment on any relevant proposed development in Kinross to help avoid any inappropriate building that would result in an increase in flood risk.
