**PERTH AND KINROSS COUNCIL (40MPH SPEED LIMIT)  
(VARIATION) (NO 34) ORDER 202X**

Perth and Kinross Council in exercise of the powers conferred on them by Sections 84(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as the "Perth and Kinross Council (40mph Speed Limit) (Variation) (No 34) Order 202X" and shall come into operation on the ..... day of .....

2. The "Perth and Kinross Council (40mph Speed Limit) Order 2012" is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the Schedule hereto.

(VARIATION) (NO 34) ORDER 202X  
SCHEDULE**

The Schedule to the “Perth and Kinross Council (40mph Speed Limit) Order 2012” requires to be varied as follows:-

- 1 At **PART I** of the **SCHEDULE** at **10. BLAIRGOWRIE** delete the existing and substitute the following:-
  - “**10. BLAIRGOWRIE**
    - (a) (A923) Coupar Angus Road  
Between a point 50 metres or thereby south of its junction of Douglas Road, Blairgowrie and a point 140 metres or thereby southeast of its junction with Golf Course Road, Rosemount, a distance of 1.33 kilometres or thereby.
    - (b) (A93) Perth Road, Blairgowrie  
From a point 453 metres or thereby south of its junction with Golf Course Road, Blairgowrie southwards to a point 152 metres or thereby south of its junction with Whiteloch Avenue, Carsie, a distance of 512 metres or thereby.”
2. At **PART I** of the **SCHEDULE** after **17B. CROOK OF DEVON** insert the following:-

“**17C. DALERB (A827)- KENMORE-KILLIN ROAD**  
From a point 186 metres or thereby northwestwards from its junction with the U177 or thereby westwards to a point 139 metres or thereby westward of its junction with the access road to the Scottish Crannog Centre for a distance of 155 metres.or thereby”
3. At **PART I** of the **SCHEDULE** at **23. GREENLOANING**, delete the existing part and substitute “**NOT USED**” at **23**.
4. At **PART I** of the **SCHEDULE** AT **30. LOGIERAIT (A827), BALLINLUIG- ABERFELDY-KILLIN ROAD** delete the existing part and substitute “**NOT USED**” at **30**.

### **Council reasons**

The Council wish to introduce or amend a 40mph speed limit on the abovementioned roads to reduce the risk of road accidents and to improve conditions for pedestrians and all road users.
