Why is this information being processed?

Who is processing this information?

Why is it lawful for the Council to process this information?

The Council is permitted to process your personal data in this way because it is lawful under the terms of Article 6(e) of the UK General Data Protection Regulation "….processing is necessary for the performance of a task carried out in the….exercise of official authority". In this case, the relevant legislation is the Climate Change (Emissions Reduction Targets) (Scotland) Act 2019.

Will any sensitive personal information (Special Category Data or information about criminal convictions etc) be processed?

It is not intended to process any sensitive personal information, although it is recognised that this may be necessary depending on applicants to SHIFT.

If so, why is it lawful for the Council to process this information?

If processing of this nature takes place, Article 9 (2)(g) of the UK General Data Protection Regulation will apply "*…processing is necessary for reasons of substantial public interest*". In this case, it is in the public interest for the authority to comply with its obligations under the Climate Change (Emissions Reduction Targets) (Scotland) Act 2019.

Will this information be shared?

Your personal information will not be disclosed to third parties unless it's necessary for us to do so in order to verify its accuracy, prevent or detect crime, protect public funds or where required by law. The Council may check information provided by you, or information about you provided by a third party, with other information held by us. How long will this information be kept for?

Personal information held on Perth and Kinross Council systems in relation to recruitment for Shift, Perth and Kinross Climate Change Commission will be kept for three years. After this it will be deleted.
