Internal and external consultation undertaken. An appraisal exercise was carried out in 2025, with an online consultation undertaken during August and September 2025 to invite views on the draft Conservation Area Appraisal from members of the public, the local community and national bodies. A public drop-in event was held at the Birnam Arts Centre on 2 September in relation to all 3 conservation areas currently being reviewed, which was attended by over 30 individuals. A letter was sent to all residents within the existing and proposed conservation area with details of the consultation and drop-in event, and a poster with details of the consultation and event was displayed on the public notice board in Spittalfield. Copies of the appraisal were made available in the phone box library as well as online. Input from residents and property owners is an important part of the appraisal process. The consultation period for comments was open until 22 September 2025. Written responses were received from Historic Environment Scotland, Perth & Kinross Heritage Trust and 12 local residents. A further 12 comments were received from local residents via the online consultation hub. A summary of the comments received is attached to the committee report in Appendix 1.
